1.1 Contractor's registration:

Self attested up to date (renewed) contractors of appropriate class and category issued by the competent authority.

- Experience of having successfully completed similar nature of works during last 7 years and include the second similar nature of works during last 7 years 2.1 ending last day of the month previous to the one in which applications are invited:
 - (i) Three works each costing not less than the amount equal to 40% of the estimated cost of work.

(ii) Two works each costing not less than the amount equal to 60% of the estimated cost of work.

or (iii) One works each costing not less than the amount equal to 80% of the estimated cost of work.

And

One completed work (either part of above or a separate one) costing not less than the amount equal to 40% of the estimated cost with some Central/State Government Organization/Central Autonomous Body/Central Public Sector Undertaking in north eastern states.

Completion certificate for the construction of similar work(s) should be in prescribed format given in Proforma-6 of the technical bid document issued by the officer not below the rank of Executive Engineer of Govt./Semi Govt. Department.

3.1 Average annual financial turnover:

Average annual financial turnover on construction works should be at least 100% of the Estimated Cost during last 3 consecutive financial year ending 2018-19.

Financial solvency: 4.1

Financial solvency certificate issued by the Scheduled Bank as per proforma given in technical bid document (Proforma-2C) for amount not below 40% of Estimated cost during current financial year.

- (i) Bankers certificates should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.
- (ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.
- G.S.T registration: 5.1

Self attested copy of G.S.T registration certificate.

EPF registration: 6.1

Self attested copy of EPF registration certificate including paid challan for the month of September, 2019.

PAN No.: 7.1

Self attested copy of PAN card.

Tender documents are to be submitted in 3 (three) separate envelopes. 1st envelop should contain Earnest Money, 2nd envelope should contain pre-qualification (technical bid document) duly filed up & signed along with relevant document as prescribed, and 3rd envelope should contain the price bid along with Terms & Condition of the Price Schedule of quantity. All 3 (three) envelopes are to be sealed in a single envelope, mentioning name of work, NIT No., closing date and time. The 3rd envelope containing price bid will be opened only for those contractors who are technically qualified as per conditions of NIT.

The completed bid document will be dropped in the tender box available at Estate Engineering Branch of the Institute up to 2.00 pm on 23.10.2019 and will be opened at 3:00PM on same day, price bid of the technically qualified agency will be opened on 25.10.2019 at 03:00 pm in presence of agencies or authorized persons thereof.
